<u>APPROVAL OF MINUTES:</u> Sue Settle made a MOTION to approve the Jan 4th, 2023 and January 20th, 2023 as corrected. Dennis Puhrman seconded, and all in favor. MOTION passed unanimously.

<u>PRESIDENT REPORT:</u> Jerry Jackson gave updates on recent projects that have been completed and status updates on outstanding items. Jerry also reported that the association's insurance carrier did not drop Golf Green and they are pursuing the renewal.

**TREASURER REPORT**: Jane Posner gave a thorough report from the January 31<sup>st</sup> financial statement as attached to these corporate records.
